

# Administrative Guidelines for Policy 7250

## Crestline Athletic Department Naming Privileges Application

Approved July 10, 2023

The following criteria have been established by the Crestline High School Athletic Department for the purpose of conferring honors and naming privileges to individuals who have made exceptional contributions to the school or athletic program. The criteria aims to uphold the values of excellence, commitment, and positive impact within the Crestline High School community.

### *Primary Criteria:*

#### 1. Significance and Contribution:

- Nominees must have demonstrated a noteworthy and positive impact on the school or athletic program. This can include exceptional athletic achievements, leadership, sportsmanship, or contributions to the broader community.

#### 2. Longevity and Commitment:

- Priority will be given to individuals who have exhibited a sustained commitment to the Crestline High School school or athletic program over an extended period. This may encompass athletes, coaches, or community members who have dedicated a substantial portion of their time and effort.

#### 3. Character and Integrity:

- Nominees should exemplify the values and character traits that Crestline High School seeks to instill, such as integrity, sportsmanship, teamwork, and a positive attitude.

#### 4. Positive Impact on Others:

- Consideration will be given to individuals who have positively influenced and inspired others within the school community. Contributions to fostering a positive culture and motivation among peers will be weighed.

#### 5. Community Involvement:

- Nominees should not only be actively engaged in the athletic program but also contribute positively to the broader community. This could involve volunteering, community service, or other forms of meaningful engagement.

*Secondary Criteria:*

6. Alumni Status:

- Alumni who have achieved success in their respective fields and brought positive recognition to the school may be considered for naming honors.

7. Family or Donor Contributions:

- While not obligatory, significant financial contributions associated with the naming will be considered, following established guidelines for honoring donors or their families.

8. Public Input:

- The Athletic Department may solicit input from the school community, including students, parents, and staff, to gather diverse perspectives and insights on potential honorees.

*Approval Process:*

9. Approval Stages:

- The nominee must first receive approval from the Athletic Director, Principal and Superintendent.
- Subsequently, the nominee must secure 75% approval from members of the naming committee
  - The naming committee is to be composed of a minimum 4 staff members and 4 community members and two Board Members.
- The Application will be open for the public to submit nominations once a year during the Month of April
- The committee will approve up to one project per year with no guarantee of a nomination being accepted.
